## WARNING: BY SIGNING THIS AGREEMENT, YOU GIVE UP THE RIGHT TO SUE FOR ANY INJURY OR DAMAGES HOWSOEVER CAUSED

To: *Anchor D Guiding & Outfitting Ltd.* (hereinafter referred to collectively as "*Anchor D*") and employees, representatives, officers and agents (hereinafter referred to collectively as "*Anchor D Employees*").

I, \_\_\_\_\_ hereby sign this agreement on behalf of myself, my personal representatives, heirs and assigns.

1. I agree as a precondition to my participation in a trail rides, wagon/sleigh rides or hunting/fishing and related activities, organized by *Anchor D* and/or *Anchor D Employees*, and in further consideration of *Anchor D* allowing me to do so, to be strictly bound by the terms of this Waiver, Assumption of Risk and Indemnity Agreement (hereinafter referred to as "*This Agreement*").

2. I acknowledge that trail rides, wagon/sleigh rides or hunting/fishing and related activities involve INHERENT RISKS that may cause SERIOUS INJURY and POSSIBLY DEATH TO PARTICIPANTS. I further recognize that back country trail, horse wagon/sleigh rides and hunting activities involve ADDITIONAL RISKS AND DANGERS.

3. I fully understand the risks and dangers associated with my participation in this trail ride, wagon/sleigh ride or hunting/fishing and related activities and ACCEPT SAME ENTIRELY AT MY OWN RISK.

4. I hereby WAIVE ANY AND ALL CLAIMS which I may have against *Anchor D* and *Anchor D Employees* and RELEASE *Anchor D* and *Anchor D Employees* from ALL LIABILITY for injury, death, property damage or any other loss sustained by me as a result of my participation in the trail ride, wagon/sleigh ride or hunting/fishing related activity, DUE TO ANY CAUSE WHATSOEVER including, without limitation, negligence on the part of *Anchor D* or *Anchor D Employees*. I further AGREE TO INDEMNIFY *Anchor D* and *Anchor D Employees* for any and all legal fees (on a solicitor and his own client basis) or costs which may be incurred in defending any lawsuit or claim I may bring against them.

5. I appreciate that This Agreement applies whether *Anchor D* is at fault or not and it limits the liability of *Anchor D Employees* to the same extent as it limits the liability of *Anchor D* even though *Anchor D Employees* are not formal parties to This Agreement. I understand that *Anchor D*, in securing execution of This Agreement by myself, is acting as agent or trustee on behalf of or for the benefit of *Anchor D Employees*, who shall to this extent be or be deemed to be parties to the Agreement.

I hereby grant permission to *Anchor D Guiding & Outfitting Ltd* to use the photograph(s) created from my participation on its website, in other company publications or promotional materials in the near future or at a later date. I acknowledge *Anchor D Guiding & Outfitting's* right to crop or treat the photograph at its discretion.
